Charlie Page, his heirs and assigns forever:

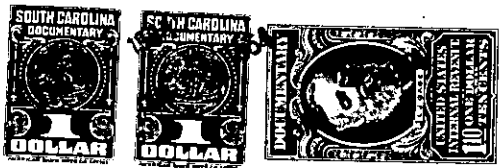
