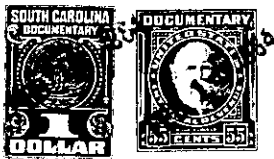
KNOW ALL MEN BY THESE PRESENTS, that we, Donald P. & Nancy G. Tetreault
