That I, GEORGE F. TOWNES, in the State aforesaid, in consideration of the sum of Four Thousand Six Hundred Fifty and 36/100 DOLLARS, and assumption of mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

CECIL CALLAHAM and KATHRYN P. CALLAHAM, their heirs and assigns forever,

ALL that piece, parcel or lot of land, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 36 of "Grand View" as shown on a plat prepared by Woodward Engineering, dated March, 1957, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book KK at page 93, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the northern side of Crestmore Drive at the joint front corner of Lots Nos. 35 and 36, running thence with the line of Lot No. 35 N. 15 - 43 W., 160 feet to an iron pin in the line of property of Graceland Cemetery; thence with the line of said property N. 74 - 17 E., 64 feet to an iron pin at the joint rear corner of Lots Nos. 36 and 37; thence with the line of Lot No. 37 S. 15 - 43 E., 160 feet to an iron pin on the northern side of Crestmore Drive; thence with the northern side of Crestmore Drive S. 74 - 17 W., 64 feet to the point of beginning.

As consideration for this deed the Grantees hereby assume payment of a mortgage held by Carolina Federal Savings and Loan Association recorded in the R.M.C. Office for Greenville County in Mortgage Book 759 at page 397, and having a present balance of \$5,349.64.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said Premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
