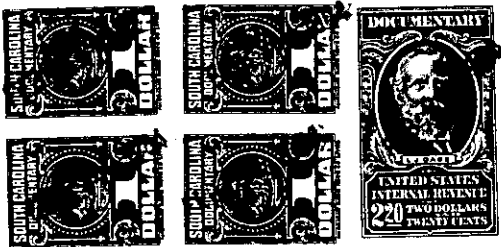

BEGINNING at an iron pin on the southern side of Walker Springs Road, joint front corner lots #46 and #34, running thence along the joint line of these lots, S. 4-56 E. 176.4 feet to an iron pin in the line of lot #35; running thence N. 84-41 W. 90.0 feet to an iron pin at the joint rear corner of lots #45 and #46; running thence N. 6-02 E. 178.4 feet to an iron pin on the southern side of Walker Springs Road; thence along the southern side of Walker Springs Road, S. 83-20 E. 86.6 feet to an iron pin, point of beginning.
