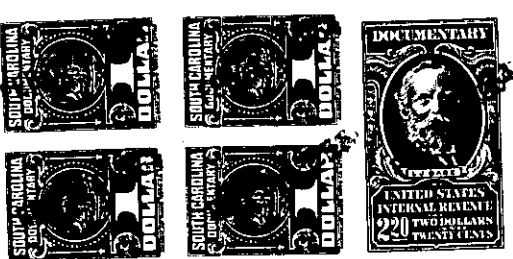

BEGINNING at an iron pin on the southern side of Strand Court, joint front corner lots #20 and #21, running thence along the joint line of these lots, S. 10-15 E. 177.6 feet to an iron pin; thence S. 70-05 W. 115.8 feet to an iron pin in the rear line of Lot #17; running thence N. 0-56 E. 24.3 feet to an iron pin; thence N. 0-34 E. 87.6 feet to an iron pin; thence N. 0-55 E. 97.5 feet to an iron pin on the southern side of Strand Court; thence along the southern side of Strand Court, the following courses and distances: S. 87-04 E. 30.0 feet to an iron pin; thence N. 82-18 E. 45.0 feet to an iron pin, point of beginning.
