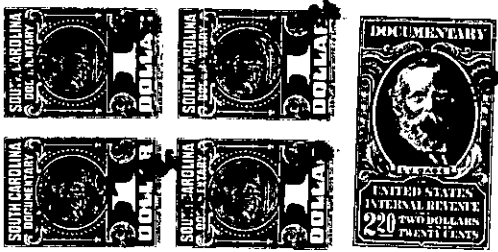

BEGINNING at an iron pin on the western side of Hastings Circle, joint front corner lots #4 and #5, running thence along the joint line of said lots, S. 73-36 W. 175.0 feet to an iron pin; thence S. 16-24 E. 90.0 feet joint rear corner lots #5 and #6; running thence along the joint line of these lots, N. 74-22 E. 158.4 feet to an iron pin on the western side of Hastings Circle; thence along the western side of Hastings Circle, which line is curved, the chord of which is N. 1-37 W. 64.5 feet to an iron pin on the western side of Hastings Circle; thence continuing along the western side of Hastings Circle, N. 16-24 W. 30 feet to an iron pin, point of beginning.
