to the grantor(s) in hand paid at and before the sealing of these presents by the grantees (s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said HOMES, INC., OF GREENVILLE, S.-C.

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina shown and designated as property of John E. Groce, Jr. on plat of a portion of McAlister Plaza dated December, 1961, revised April, 1963, by Piedmont Engineering Service, recorded in the office of the R.M.C. for Greenville County in Plat Book RR at page 123, and being more particularly described with reference to said plat as follows:

BEGINNING at a point on the southwesterly boundary of parking area, joint front corner of property now or formerly of Homes, Inc., of Greenville, S. C., and property conveyed herein and running thence along the common boundary of said properties, S. 33-39 W. 185.2 feet to a point on the northeastern boundary of a 15-foot alley; thence turning and running along said boundary of said alley, N. 61-08 W. 20 feet to a point on said boundary; thence turning and running N. 33-39 E. 186.8 feet, more or less, to a point on the southwestern boundary of parking area; thence turning and running along said southwestern boundary, S. 56-21 E. 20 feet to the point of beginning. This is the southeastern portion of the property designated on said plat belonging to John E. Groce, Jr. and is 20 feet in width.

This conveyance is subject to all restrictions and conditions contained in deed from McAlister Corp. to John E. Groce, Jr., easements, rights of way and set back lines indicated on said plat and other restrictions and conditions of record.

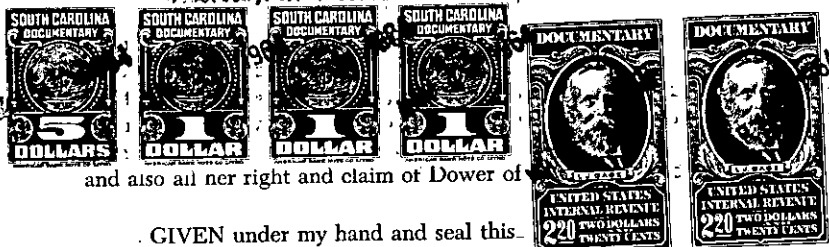
