All that certain tract or parcel of land, situate, lying, and being in the City of Green-ville, county of Greenville, State of South Carolina, on the north side of Fisher Drive, being shown as the southern portion of Lots Nos. 31 and 32 on plat of Marsmen, Inc., recorded in the R.M.C.
