in consideration of One Thousand Seven Hundred Fifty & no/100 ----- Dollars,

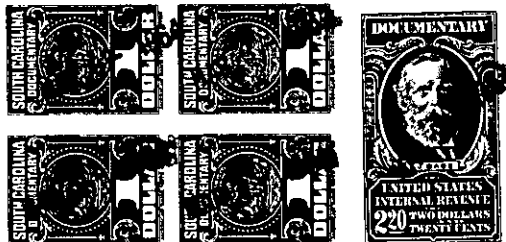

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 27 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book XX at Page 9, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northeastern side of Penarth Street at the joint front corner of Lots 19 and 27 and running thence with the Northeastern side of Penarth Street S 31-07 E 100 feet to a point at the joint front corner of Lots 27 and 28; thence N 58-53 E 193.6 feet to a point at the joint rear corner of Lots 27 and 28; thence N 09-59 W 74.5 feet to a point at the joint rear corner of Lots 20, 25 and 27; thence S 82-16 W 77 feet to a point at the joint rear corner of Lots 19 and 20; thence S 58-53 W 150 feet to the point of BEGINNING.
