KNOW ALL MEN BY THESE PRESENTS, that We, M. F. VAUGHAN, MAMIE G. VAUGHAN, FLOYD L. CARROLL, and ELIA V. CARROLL,

in consideration of Fifteen Thousand and no/100 (\$15,000.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto  
THEODORE C. THEODOROU, his heirs and assigns, forever:

All that tract of land in the County of Greenville, State of South Carolina, in Grove Township, containing 56 acres, more or less, as shown on Plat of Marshall F. Vaughan dated March, 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book GGG at Page 75, 72, 73, 74 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of Griffin Mill Road, corner of property of Griffin and running thence along his line in the following courses and distances to-wit: N. 71-30 W., 154 feet; N. 68-30 W., 142 feet; N. 67-55 W., 121 feet; N. 63-30 W., 331.3 feet; thence along the property of Elliot following courses and distances to-wit: N. 63-15 E., 397.4 feet to an iron pin; N. 8 W., 324 feet to an iron pin; N. 36-48 W., 177.5 feet to an iron pin; N. 7-04 W., 120 feet to an iron pin; N. 42-34 W., 753 feet to an iron pin; N. 21-18 W., 145.2 feet to an iron pin; thence along the property of Barker and Burns, N. 73-33 E., 1887.2 feet to an iron pin; thence S. 16-27 E., 112.5 feet to an iron pin thence along 1.12 acres sold to Campbell, S. 26 W., 200 feet; thence S. 64 E., 243 feet to a point in the center of Griffin Mill Road; thence with the center of said road, S. 26-33 W., 710.8 feet to an iron pin; thence S. 23-23 W., 500 feet to an iron pin; thence S. 23-03 W., 610 feet to an iron pin; thence S. 30-18 W., 290 feet to the point of beginning. This is the same property conveyed to us in Deed Book 644 at page 301 as shown in Plat Book "A", page 361, less two conveyances out by the grantors, deed Book 698, page 5, conveying a one acre tract to Bobby Joe Campbell, et al in Deed Book 727 at page 377, conveying 1.75 acres to Dewey E. Campbell. The deed to Bobby Campbell shows a depth of 218 feet which was measured from the bank whereas the plat shows a depth of 243 feet. The grantee would receive only that property left after the conveyance of the 2.75 acres to the two Campbells as more fully described in their deeds.
