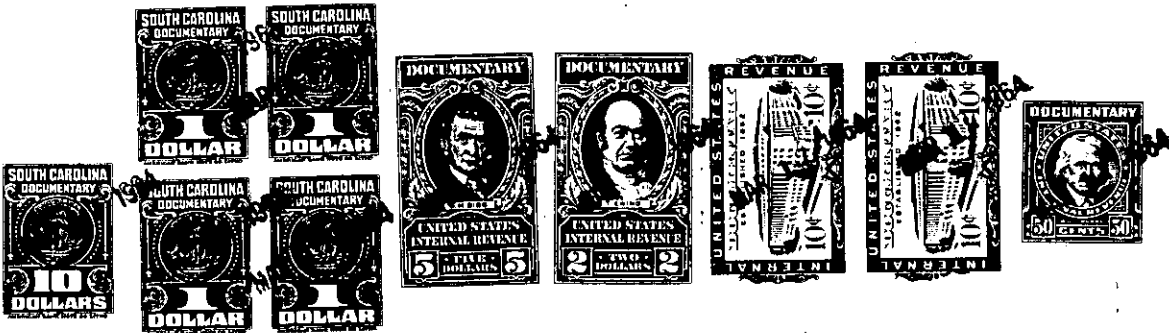

ALL that lot of land in Greenville County, South Carolina known and designated as Lot Number Thirty-Six (36) of Section One of Chanticleer, as shown by a plat thereof made by R. K. Campbell, dated September 29, 1962, and recorded in the RMC Office for Greenville County in Plat Book YY at page 97; and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of East Seven Oaks Drive at the joint front corner of Lots 35 and 36 and running thence with the northern side of East Seven Oaks Drive S. 80 - 24 W. 52.6 feet to an iron pin; thence still with the northern side of East Seven Oaks Drive S. 77 - 34 W. 67.4 feet to an iron pin at the joint front corner of Lots 36 and 37; thence with the line of Lot 37 N. 0 - 59 W. 193.2 feet to an iron pin in the rear line of Lot 28; thence with the rear line of Lots 28 and 29 N. 84 - 01 E. 120 feet to an iron pin at the joint rear corner of Lots 35 and 36; thence with the line of Lot 35 S. 0 - 35 E. 189.3 feet to the beginning corner.

This property is subject to easements and restrictions shown on said plat and to restrictive covenants recorded in the RMC Office for Greenville County in Vol. 713 at page 221 and Vol. 716 at page 321.

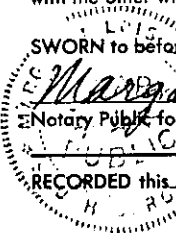
