unto C. F. Long, his heirs and assigns forever:

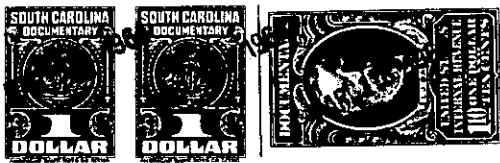
