to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. R. TABER, JR and ANNE F. TABER, their heirs and assigns, forever:

ALL that lot of land, with the buildings and improvements thereon, situate on the Northeast side of Lullwater Road, in the City of Greenville, in Greenville County, S. C., being shown as Lot No. 36 on plat of Northside Garden, made by Dalton & Neves, Engineers, November 1946, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book S, Pages 16 and 17, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeast side of Lullwater Road at joint fron corner of Lots 35 and 36, and runs thence along the line of Lot 35, N. 54-56 E., 220.8 feet to an iron pin; thence S. 34-48 E., 85 feet to an iron pin; thence with the line of Lot 37, S. 54-56 W., 217.2 feet to an iron pin on the Northeast side of Lullwater Road; thence along Lullwater Road, N. 37-13 W., 85.08 feet to the beginning corner.

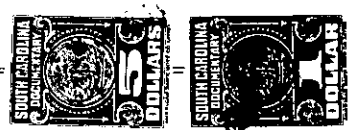
