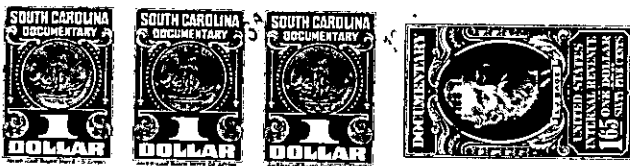
KNOW ALL MEN BY THESE PRESENTS, that C. Otto White, Jr., Realtor,
