the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto William H. Richardson Jr. and Elizabeth L. Richardson, their heirs and assigns forever,

All that lot of land, situate on Rockingham Road in Greenville County, State of South Carolina, being shown as Lot No. 65 Rockingham Road, on plat of Barksdale subdivision made by Dalton & Neves, Engineers, December 1959, recorded in the R. M. C. Office for Greenville County S. C. in Plat Book QQ, Pages 118-119 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the south side of Rockingham Road, joint front corner of Lots 64 and 65 and running along the line of Lot 64 S. 34-17 E. 252.1 feet to an iron pin, joint rear corner of Lots 64 and 65; thence S. 56-57 W. 325 feet to an iron pin, joint rear corner of Lots 65 and 66; thence N. 0-54 W. 323 feet to an iron pin on Rockingham Road, joint front corner of Lots 65 and 66; thence N. 73-56 E. 76 feet to an iron pin; thence continuing with Rockingham Road N. 55-58 E. 74.1 feet to an iron pin, the beginning corner.
