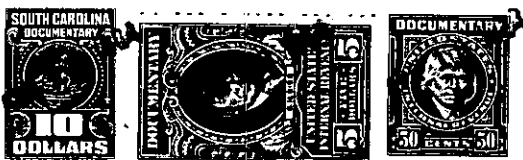
KNOW ALL MEN BY THESE PRESENTS, that I, Coleman B. Strange
