in consideration of Seven Hundred Eighty Five & NO/100 (\$785.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Joan Southerlin, her heirs and assigns forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 26, as shown on a plat of Pinewood Estates by H. S. Brockman, Surveyor, dated November 1958 and recorded in the R. M. C. Office for Greenville County in Plat Book MM, at Page 55, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Christie Drive, joint front corners of Lots 25 and 26 and running thence along the line of said lots, N. 88-05 E. 170 feet to iron pin line of Lot 15; thence running with line of said lot, N. 1-55 W. 90 feet to iron pin rear corner of Lot 27; thence running with line of Lot 27, S. 88-05 W. 170 feet to iron pin on Christie Drive; thence running with Christie Drive, S. 1-55 E. 90 feet to iron pin point of beginning.

NO residence to cost less than Ten Thousand (\$10,000.00) Dollars shall be erected on any lot; no residence shall be erected on lots nearer than thirty-five (35) feet to the front line; no residence shall be built on any lot unless said lot has seventy (70) feet to more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes only.

THIS conveyance is subject to all easements and rights of way of record.
