unto RANDALL D. GRICE and BARBARA W. GRICE, their heirs and assigns:

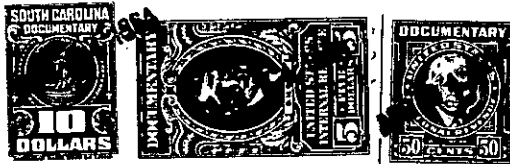
ALL that piece, parcel or lot of land with the buildings and improvements thereon, situate,

to said plat, the following metes and bounds to-wit:
