

KNOW ALL MEN BY THESE PRESENTS That L.M. BROWN

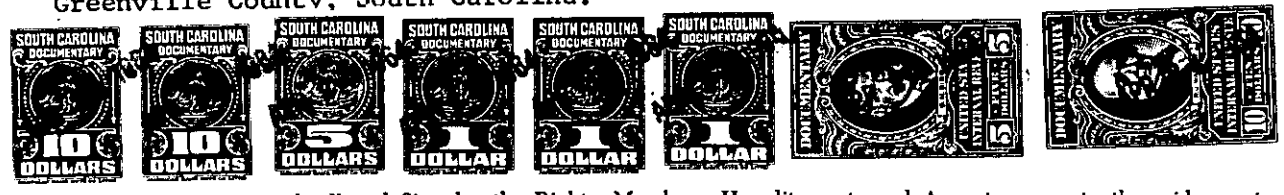

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto
HARRY DEAN McALLISTER AND ANN C. McALLISTER:

All that piece, parcel or lot of land situate, lying and being on the Northern side of Lenhardt Road near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 23 as shown on a plat prepared by Dalton & Neves, Engineers, dated June, 1960, entitled "Parkdale", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book RR at page 55, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Lenhardt Road at the joint front corner of Lots Nos. 23 and 24, and running thence with the line of Lot No. 24 N. 38-0 W. 160 feet to an iron pin in the line of Lot No. 49; thence with the line of Lot No. 49 S. 52-0 W. 86.9 feet to an iron pin on the Eastern side of Parkdale Drive; thence with the Eastern side of Parkdale Drive S. 27-57 E. 137.5 feet to an iron pin; thence with the curve of the intersection of Parkdale Drive and Lenhardt Road, the chord of which is S. 77-58 E., 32.2 feet to an iron pin on the Northern side of Lenhardt Road; thence with the Northern side of Lenhardt Road N. 52-0 E. 90 feet to the point of beginning.
