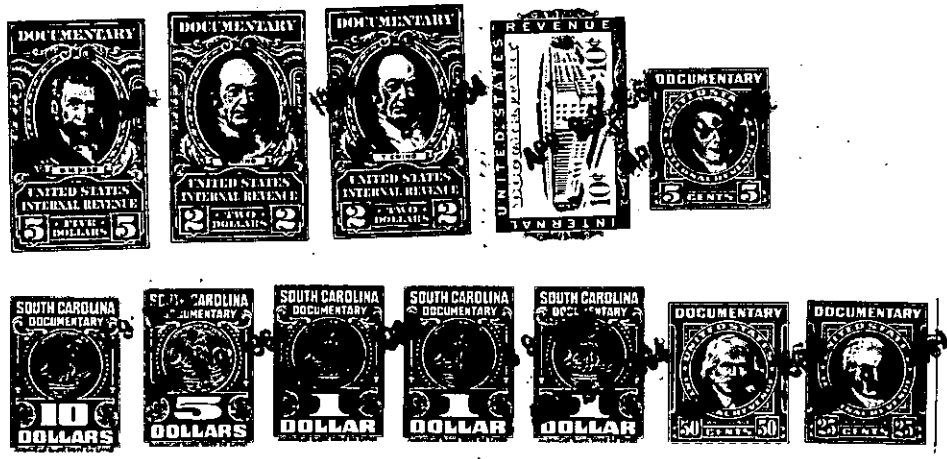

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being in the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as the greater portion of Lots 18, 19 and 20, Block E, on Plat of Stone Estates, plat of which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book G, at page 292, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of Druid Street at the corner of Lot No. 21 which point is 250 feet Southwest of the intersection of Camp Road and Druid Street; and running thence along the line of Lot No. 21 S. 78-38 E. 145 feet to an iron pin in the line of Lot No. 21 at the corner of a fifteen foot alley; thence along the line of said alley S. 11-22 W. 75 feet to an iron pin at a sharp turn in the said alley in the line of Lot No. 17; thence along the line of said Lot No. 17, also being the North line of the said alley, N. 78-38 W. 145 feet to an iron pin on the Eastern side of Druid Street; thence along Druid Street N. 11-22 E. 75 feet to the beginning corner.
