All that piece parcel or lot of land in Butler Township, Greenville County, State of South Carolina, being known as Lot No. 27 Timrod Way, of Section No. 2, Parkins Lake Development near Greenville, S. C. according to a plat made October 22, 1962 by R. K. Campbell, Engineer and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "YY" Page 93 and being more particularly described as follows:

BEGINNING at an iron pin on the North side of Timrod Way, joint front corner of Lots 26 and 27 and running along the line of Lot 26 N. 56-05 W. 184.4 feet to an iron pin, joint rear corner of Lots 26 and 27; thence N. 33-50 E. 150 feet to an iron pin, joint rear corner of Lots 27 and 28; thence along the line of Lot 28 S. 56-05 E. 184.6 feet to an iron pin on Timrod Way, joint front corner of Lots 27 and 28; thence along Timrod Way S. 33-55 W. 150 feet to an iron pin, the beginning corner.
