All that piece, parcel or lot of land, the same being a part of Lot 113, Section A as shown on a plat entitled "A subdivision of Woodside Mills, Greenville, South Carolina" recorded in the R.M.C. Office for Greenville County in Plat Book X at page 117, on which there is situated a small "shell" house. It is the in-

tention of this deed to convey to the Grantees herein only that land on which the smaller house referred to above is situated.

The whole of Lot 113, Section A referred to above was conveyed to the Grantor and her husband, Ramsey L. Harbin, now deceased, by deed recorded in Deed Book 410 at page 04.

Subsequently, a "shell-type" house was erected on the rear portion of the lot.
