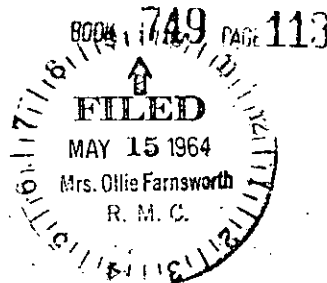

All that certain piece, parcel or lot of land situate, lying and being in Chick Springs Township, Greenville County, South Carolina, and being a portion of that property of the Grantors described and designated in Title To Real Estate dated February 21, 1957 and recorded in the R. M. C. Office of Greenville County in Book #587 on Page #302; said lot of land herein conveyed being more particularly described as follows:

Beginning at a point on the eastern edge of an unnamed dirt, all-weather County, Road 1,316 feet along the eastern edge of said unnamed road from the present center of hard surfaced road # S-23-279, commonly referred to as Reid School Road and which leads from Highway #29 in a westerly direction, and running thence along said unnamed road in a northerly direction 105 feet to a point; thence in a south easterly direction and parallel to the southernmost lot line of J. W. Clark, Jr. and Joyce Clark for 220 feet to a point; thence in a southerly direction for 105 feet to a point; thence in a westerly direction 220 feet to the point of beginning.
