in consideration of Fifty-Five Hundred and No/100-----(\$ 5500.00)-----Dollars,

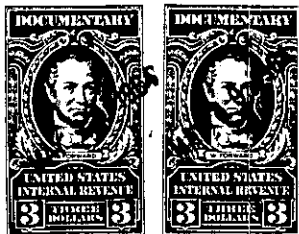
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
