themselves, but if they were unable to agree upon a division or if they found it impracticable to divide the same in kind, then his Executors should sell his real estate at public auction and to the highest bidder, after due advertisement, further providing that his Executors were to execute deeds to the purchasers. The children of W.C. Chandler having found it impossible and impracticable to divide the real estate in kind or by exchange of cash among themselves, by a written agreement and so stated in the instrument that all of the real estate should be sold at public auction and that the executors make deeds and convey the same in accordance with authority contained in the will. The property herein described was sold at auction on the 14th day of September, 1963, after extensive advertisement, the grantees being the highest and sufcessful bidder.
