to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Fannie A. Williams, all my right, title and interest in and to,

All that piece, parcel or lot of land in the county of Greenville, state of South Carolina, in the city of Greenville, being known and designated as Lot No. 13 and one-half of Lot No. 12 as shown on plat of Nicholtown No. 4, recorded in the RMC Office for Greenville County in plat book N, page 139, and being more particularly described as follows:

Beginning at an iron pin on the southwest side of Horney Street, in the center of Lot No. 12 and running thence through the center of Lot No. 12, S. 53-43 W. 134.7 feet more or less to a point in the center of the rear line of lot No. 12; thence N. 29-04 W. 60.3 feet to an iron pin at the northwest corner of Lot No. 13; thence N. 53-43 E. 127.3 feet to an iron pin in the southwest side of Horney Street; thence with said Street S. 36-17 E. 60 feet to the point of beginning. Horney Street is now known as Lark Street.

This is the same lot of land conveyed to James L. Williams and Fannie A. Williams by deed dated November 6, 1953 recorded in deed vol. 488 at page 325. Subsequently, James L. Williams died intestate March 18, 1964 leaving as his sole heirs and distributees at law, his wife, Fannie A. Williams, and his brothers and sisters, Bennie Williams, Eula B. Smith, Louise W. Walton, John D. Williams, Harvie Williams, Robert T. Williams, Ida Lee Williams and Moss Williams.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
