in consideration of Two Thousand and No/100 -- (2,000.00) -- Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Allen Terrell, Jr., his heirs or Assigns:

All that certain piece, parcel or lot of land, lying and being situate in Austin Township, Greenville County, State of South Carolina, being known and designated as lot No. 30 in the Subdivision known as Dalewood Heights, plat of said subdivision being recorded in the Greenville County R. M. C. Office, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South-East side of Bramlett Street, joint corner with lot No. 31, and running thence along said lot S. 47-17 E. 261.9 feet to an iron pin; thence S. 42-43 W. 125.8 feet to an iron pin in or near center of drainage ditch; thence down drainage ditch N. 72-55 W. 290.5 feet to a point and pin on Bramlett Street; thence along said Street N. 42-43 E. 251.6 feet to the beginning corner, and being a portion of the same lands which are described in the will of the said D. L. Bramlett, deceased, will on file in the Office of the Probate Judge for Greenville County in file 534, Apt. 3.

Grantors herein do reserve a drainage easement of 5 feet along western line as shown on the above mentioned recorded plat.

This conveyance is made subject to the following restrictions:

- 1- No building is to be erected or used for commercial purposes on said lot, (Lots 1,2,3,4,5 and 6 in subdivision are designated for commercial purposes;
- 2- Any dwelling erected on said lot shall be at least 30 feet from any street on which it fronts; shall contain at least 1200 Sq. ft. of floor space on first floor, exclusive of porches and garage; shall be completed before being occupied; and shall be equipped with a satisfactory septic tank or connected to sewer;
- 3- No outbuildings with the exception of a garage shall be erected within 75 feet of any street on which lot fronts;
- 4- No pigs or goats are to be kept on said lot;
- 5- Any fence erected or used for the retention of animals other than domestic pets shall be at least 125 feet from any street on which lot fronts.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any-wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s) heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s) heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
