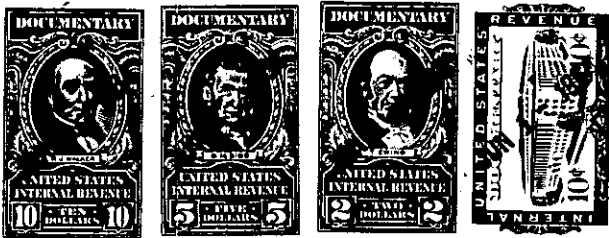
KNOW ALL MEN BY THESE PRESENTS, that We, Patrick H. Grayson, Jr. and Ann E. Grayson,

in consideration of Fifteen Thousand, Nine Hundred and No/100-----(\$ 15,900.00)--Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Rox W. Pollard, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, lying on the Northeastern side of Richbourg Drive, being known and designated as Lot No. 21 of a subdivision known as Wade Hampton Terrace as shown on a plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book KK at Page 15, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeastern side of Richbourg Drive, joint front corner Lots Nos. 21 and 22 and running thence with the joint line of said lots, N. 77-44 E. 145.4 feet to an iron pin; thence N. 15-16 W. 105.05 feet to an iron pin, joint rear corner Lots Nos. 20 and 21; thence with the joint line of said lots, S. 71-49 W. 153.7 feet to an iron pin on Richbourg Drive; thence with Richbourg Drive, S. 20-37 E. 90 feet to the beginning corner; being the same conveyed to us by Joseph M. Bearden by deed dated March 20, 1959, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 619, at Page 471.
