the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto **M. L. LANFORD, JR.,** his heirs and assigns forever;

ALL that lot of land in Greenville County, South Carolina known and designated as Lot Number Seventy-Nine (79) of Section One of Chanticleer, as shown by a plat thereof made by R. K. Campbell, dated September 29, 1962, and recorded in the R.M.C. Office for Greenville County in Plat Book YY at page 97; and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southwestern side of West Seven Oaks Drive at the joint front corner of Lots 78 and 79 and running thence with the southwestern side of West Seven Oaks Drive S. 64 - 08 E., 60 feet to a pin; thence still with the southwestern side of West Seven Oaks Drive S. 58 - 59 E., 60 feet to a pin at the joint front corner of Lots 79 and 80; thence with the line of Lot 80, S. 25 - 53 W., 190.5 feet to a pin; thence N. 64 - 20 W., 120 feet to a pin at the rear corner of Lot 78; thence with the line of Lot 78, N. 25 - 58 E., 196.3 feet to the beginning corner.

This property is subject to easements and restrictions shown on said plat and to restrictive covenants recorded in the R.M.C. Office for Greenville County in Vol. 713 at page 221 and Vol. 716 at page 321.
