the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

RUSSELL C. WYNN, His heirs and assigns forever:

All our undivided interest in and to that certain piece, parcel or tract of land situate in Greenville County, State of South Carolina, designated as Tract No. 5 of the Minnie H. Wynn Estate, as shown on plat thereof made by J. C. Hill, and as revised January, 28th, 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book CCC at page 171, and according to said plat, having the following metes and bounds, to wit:
