to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William H. Martin, Jr., his heirs and assigns forever:

All my undivided one-half interest in and to that certain piece, parcel or lot of land on the northeasterly side of Merlock Drive in the State of South Carolina, County of Greenville, being known and designated as Lot No. 13 on plat made by C. C. Jones, Engineer, dated October, 1954 and as recorded in the RMC Office for Greenville County in Plat Book HH, at Page 119, and having, according to said plat, the following metes and bounds, to-wit:
