C., as Federal Housing Commissioner, Grantor, for and in consideration of the sum of FOURTEEN THOUSAND SEVEN HUNDRED FIFTY AND 00/100----DOLLARS (\$14,750.00----) and other valuable considerations, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto BRUCE B. BALLENGER, C. H. BRADHURN AND C. M. HALL TRUSTEES FOR SAINT JOHN METHODIST CHURCH, THEIR SUCCESSORS AND ASSIGNS Grantee(s), and to the heirs and assigns of said Grantee(s), the following described real estate situate in the County of GREENVILLE, State of South Carolina, to wit:

All that piece, parcel or lot of land situate, lying and being in Greenville County, S.C., known and designated as Lot No. 202 as shown on a plat of the subdivision of South Forest Estates Addition No. 1, recorded in the RMC Office for Greenville County in Plat Book EE, page 195.
