(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by  
 these presents do grant, bargain, sell and release unto the said John Hames May and  
James Edward May, their heirs and assigns,

all that piece, parcel or lot of land in Saluda Township, Greenville

County, State of South Carolina, near Marietta, southwest of and near the Tram-  
 mell Road, and having the following metes and bounds, to-wit:

BEGINNING at a point, iron pin, joint corner with other prop-  
 erty of Grantor and with the Conner and Fultz properties, and running  
 thence N. 66-15 W. 177 feet to a point, iron pin; thence S.25-30 W.  
 503.6 feet to a point, iron pin, in Hall property line; thence with the  
 Hall property line, S. 78-35 E. 177.8 feet to a point, iron pin, joint  
 corner with other property of Grantor; thence with line of said other  
 property of Grantor, N. 26-30 E. 465.5 feet, more or less, to beginning  
 corner; and containing One and 96/100 (1.96) acres, more or less.

 ning thence S. 26-30 W. 34.8 feet to a point, iron pin, joint corner  
 with other property of Grantor; thence with line of said other property  
 of Grantor, S. 57-15 E. 207.4 feet to a point, iron pin; thence S.4-45  
 E. 100 feet to a point, iron pin, by branch; thence along branch as the  
 property line, N. 55-30 E. 84 feet to a point, stake in branch; thence  
 N. 27-00 E. 82.4 feet to a point, stake in branch; thence over iron pin  
 on bank of branch, N. 66-15 W. 299 feet to the beginning corner; and
