in consideration of ONE THOUSAND SIX HUNDRED AND NO/100-----(\$1,600.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto NORMAN A. ROPER, HIS HEIRS AND ASSIGNS:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated at Lot Number 26 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R.M.C. Office for Greenville County in Plat Book MM at Page 127, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northeastern side of Glacier Street at the joint front corner of Lots 25 and 26 and running thence with the Northeastern side of Glacier Street S 25-13 E 115.7 feet to a point; thence following the curvature of the Northeastern intersection of Glacier Street with Lawnview Court (the chord of which is S 74-46 E 38 feet) to a point; thence with the Northwestern side of Lawnview Court N 55-40 E 135.3 feet to a point at the rear corner of Lot 26; thence N 25-13 W 118.9 feet to a point at the joint rear corner of Lots 25 and 26; thence S 64-47 W 162.5 feet to the point of beginning.
