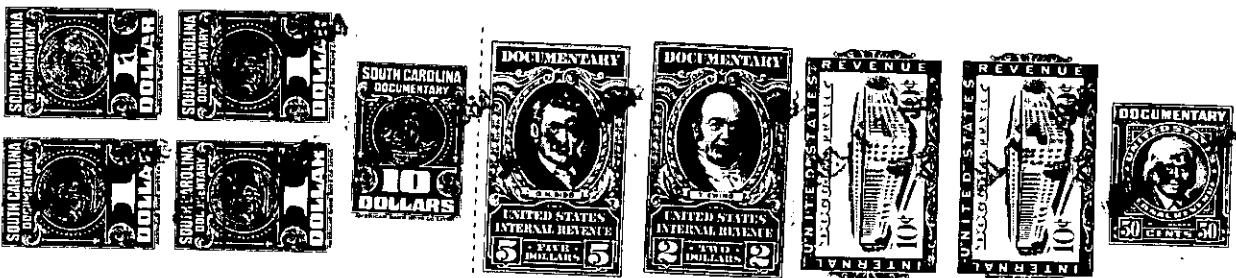
Seven Thousand and no/100 -----Dollars,
the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto **J ALVIN GILREATH, his Heirs and Assigns forever;**

ALL that lot of land in Greenville County, South Carolina known and designated as Lot Number Seventy-Two (72) of Section One (1) of Chanticleer, Inc. as shown by a plat thereof made by R. K. Campbell, dated September 29, 1962, and recorded in the R.M. C. Office for Greenville County in Plat Book YY at page 97; and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southwestern side of West Seven Oaks Drive at the joint front corner of Lots 71 and 72 and running thence with the southwestern side of West Seven Oaks Drive, S. 56 - 39 E., 60 feet to a pin; thence still with the southwestern side of West Seven Oaks Drive, S. 68 - 08 E., 60 feet to a pin at the joint front corner of Lots 72 and 73; thence with the line of Lot 73, S. 22 - 08 W., 202.1 feet to a pin at the rear corner of Lots 72 and 73; thence with the rear line of Lot 72, N. 52 - 12 W., 170 feet to a pin at the rear corner of Lots 71 and 72; thence with the line of Lot 71, N. 37 - 06 E., 173.1 feet to the beginning corner.
