All that certain piece, parcel or lot of land situate, lying and being in Cleveland Township, County of Greenville, State aforesaid, at Caesar's Head being shown as all of Lot No. 41 on plat entitled Section A of Paris Mountain - Caesar's Head Company property, prepared by R. E. Dalton, Engineer, in October, 1924, which plat is recorded in the R.M.C. Office for Greenville County, S. C., and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Southside Drive, at the joint front corner of Lots 43 and 41; thence with the joint line of said lots, and crossing an iron pin, S. 19-20 E. 170 feet more or less to an iron pin; thence in a southeasterly direction 42 feet to an iron pin at the joint rear corner of Lots 41 and 39; thence with the joint line of said lots, N. 0-23 W. 170 feet, more or less, crossing an iron pin, to an iron pin on the south side of Southside Drive; thence with said street, N. 89-33 W. 50 feet to an iron pin; thence continuing with the said street, S. 78-49 W. 50 feet to point of beginning.

This conveyance is made subject to the following restrictions which are deemed covenants running with the land: (1) this property may be used for residential purposes only and no building, other than a one-family dwelling, may be erected thereon, garages and out-buildings excluded; and (2) no hotel, inn, boarding house, cafe, restaurant, eating establishment or any establishment of a commercial nature may be erected or operated on these premises.

This deed is to correct an error made in the original conveyance to the Grantee of the wrong residential lot. By deed recorded in Book 384, 513, R.M.C. Office, the Grantor conveyed to Sally C. Hugenin Lot No. 43 of the above sub-division, whereas it was actually intended to convey Lot 41; subsequently, Sally C. Hugenin conveyed to Mary B. Dudley Lot 43 as will appear by reference to Deed Book 436 at page 325. The Grantor and Grantee herein as well as Sally C. Hugenin intended by all conveyances to convey Lot 41 as opposed to Lot 43 and this deed is made in order to correct the original by mistaken identity of the property intended to be conveyed and transferred from the above Grantor to Sally C. Hugenin and thence to Mary B. Dudley.
