to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto **GREENVILLE COUNTY, SOUTH CAROLINA**, a political subdivision of the State of South Carolina:

ALL that piece, parcel or tract of land, consisting of 7.67 acres, situate, lying and being on the Southerly side of a 70-foot right of way to be conveyed to the South Carolina Highway Department contiguous to the Southern side of the right of way of Interstate Highway 85, in Butler Township, Greenville County, South Carolina, as shown on a plat entitled "Property of Greenville County" made by Davis & Floyd Engineers, Inc., June 1, 1964 and recorded in the R.M.C. Office for Greenville County in Plat Book HHH at page 43, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin in the Southerly side of said 70-foot right of way and running thence S. 35-17 E. 380 feet to an iron pin; thence N. 54-43 E. 993 feet to an iron pin; thence N. 35-17 W. 176 feet to an iron pin; thence S. 54-43 W. 213 feet to an iron pin; thence N. 35-17 W. 204 feet to an iron pin on the Southerly side of said 70-foot right of way; thence with the Southerly side of said 70-foot right of way S. 54-43 W. 780 feet to an iron pin, the point of beginning.

The above described tract of land is a portion of the property conveyed to the Grantor herein by Fiber Industries, Inc. by its deed dated December 17, 1963 and recorded in the R.M.C. Office for Greenville County in Deed Book 739 at page 148.

The within described property is conveyed to the Grantee herein for the purpose of constructing and operating thereon a sewage disposal plant suitable to the industrial and sanitary requirements of the Grantor herein, its successors and assigns, and other users within the general area of the above described premises.
