That I, J. FRANK WILLIAMS

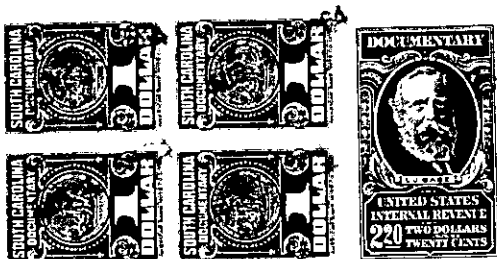
in consideration of the sum of SIXTEEN HUNDRED and no/100 (\$1600.00) ----- DOLLARS,

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot 129 on a plat of Western Hills recorded in the R. M. C. Office for Greenville County in Plat Book "QQ" at pages 98-9 and having, according to said plat, the following metes and bounds, to-wit:
