the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto William R. Whitmire, his heirs and assigns forever:

All of that certain tract of land in Gantt Township, Greenville County, State of South Carolina, being located just off the White Horse Road and being known as Lot No. 1 as shown on plat of Property of Grace M. Whitmire Estate recorded in the R. M. C. Office for Greenville County in Plat Book XX at page 98 and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on private road shown on said plat at the joint corner of Lots Nos. 1 and 2, and running thence with the joint line of said lots, S. 6-12 E. 192.8 feet to iron pin; thence S. 87-34 W. 187 feet to iron pin; thence along line of property of West Gantt Baptist Church, N. 23-40 W. 209 feet to iron pin on said private road; thence along said road, S. 88-51 E. 186.0 feet to the beginning corner.
