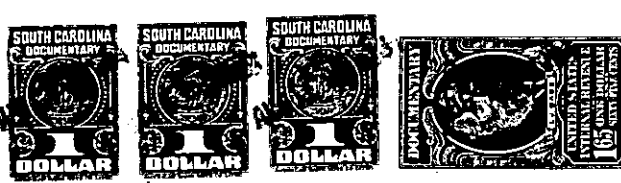
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Earl B. Flynn and Anne G. Flynn and their heirs and assigns forever:

All that certain parcel or lot of land situated on the north side of Cumberland Drive near State Highway No. 101, about one and one-half miles northwestward from the City of Greer, Oneal Township, Greenville County, State of South Carolina, and being Lot No. 4 of WOBURN COURT, property of W. Dennis Smith, according to survey and plat by John A. Simmons, Registered Surveyor, dated December 11, 1963, recorded in Plat Book ____, page ____, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:
