All that certain lot of land in the State of South Carolina, County of Greenville, on the western side of Stenhouse Drive, shown on a plat entitled "Property of W. Roscoe Jones and Harold B. McKinney", prepared May 18, 1962 by C. O. Riddle, R.L.S., recorded in Plat Book AAA at Page 111 in the R.M.C. Office for Greenville County, and shown as Lot 5, the said lot being the third lot in a southerly direction from the intersection of Stenhouse Drive and a County Road, and having according to said plat the following metes and bounds:
