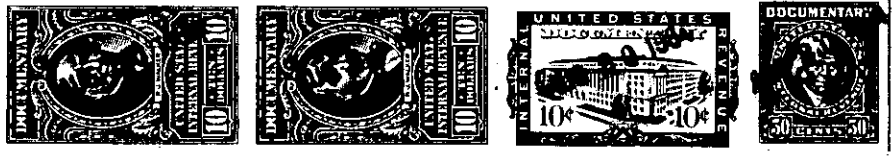

ALL that certain piece, parcel or lot of land, with the buildings and improvements thereon, situate on the West side of Holmes Drive, in Greenville Township, Greenville County, in the City of Greenville, South Carolina, and being known and designated as Lot No. 94 of the Property of Central Development Corporation, according to a plat of record in the RMC Office for Greenville County, S. C. in Plat Book "BB", at Page 22 and 23, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Holmes Drive at joint front corner of Lots 93 and 94, and running thence with the line of Lot 93, N. 78-42 W., 166 feet to an iron pin; thence S. 7-51 W., 40.4 feet to an iron pin; thence S. 57-51 W., 50.4 feet to an iron pin; thence with the line of Lot 95, S. 78-45 E., 200.4 feet to an iron pin in the West side of Holmes Drive; thence along the West side of Holmes Drive, N. 11-18 E., 75 feet to the beginning corner.

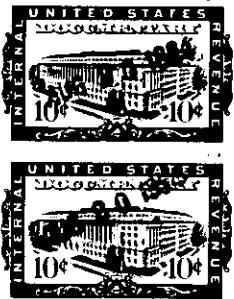
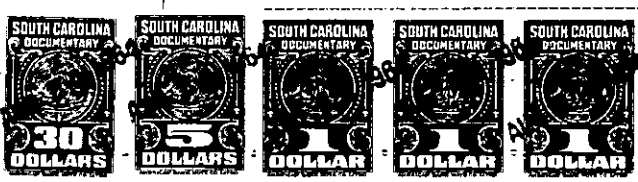
