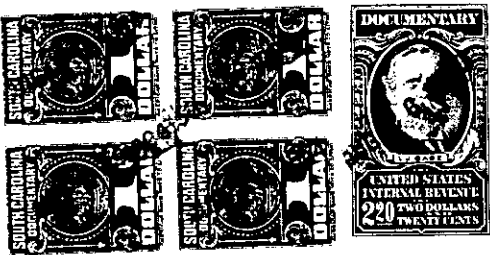
KNOW ALL MEN BY THESE PRESENTS, that I, Curtis W. Evans
