Mack Richardson, R.L.S., in January 1959, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 & 37, and having according to said plat the following metes and bounds:

Beginning at an iron pin on the southern side of Vicki Circle at the joint corner of Lots 35 and 36 and running thence along the southern side of Vicki Circle S. 85-29 E. 100 feet to an iron pin the joint front corner with lot 34, thence along line of Lot 34 S. 4-31 E. 230.4 feet to an iron pin; thence N. 77-58 W. 100.86 feet to an iron pin; thence along the line of Lot 36, N. 4-31 E. 216.9 feet to an iron pin on the southern side of Vicki Circle, the point of beginning.
