CORRECTION DEED

KNOW ALL MEN BY THESE PRESENTS, that SITTON BUICK COMPANY, INC. (also Sitton Buick Company, Inc. of Greenville, S. C.), a Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of One (\$1.00) Dollar and correction of previous deed hereinafter referred to

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto HUMBLE OIL & REFINING COMPANY, a Delaware Corporation,

ALL that certain piece, parcel or lot of land situate, lying and being at the northwesterly intersection of North Pleasantburg Drive (S. C. Highway 291) and Galphin Drive, near the City of Greenville, County of Greenville, State of South Carolina, being shown on plat of property prepared for the grantee, dated July 24, 1963, prepared by Webb Surveying & Mapping Co., and on plat recorded in Plat Book AAA, at page 83, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin where the northwesterly side of Galphin Drive intersects the northeasterly side of North Pleasantburg Drive, and running thence along the northeasterly side of North Pleasantburg Drive, N. 45-37 W. 100 feet to a point; thence continuing along North Pleasantburg Drive, N. 47-29 W. 102.9 feet to a point; thence turning and running N. 30-47 E. 470.4 feet to a point on the southwesterly side of Hillrose Avenue; thence turning and running S. 60-15 E. 246.60 feet to a point on the northwesterly side of Galphin Drive; thence turning and running along the northwesterly side of Galphin Drive, S. 36-08 W. 522 feet to the point of beginning.

TOGETHER with all the right, title and interest of the grantor in and to the right-of-way lying within the extension of the side lines to the center of North Pleasantburg Drive and lying within the extension of the front and rear lines to the center line of Galphin Drive and within the extension of the side lines to the center of Hillrose Avenue.

Grantee to pay 1964 taxes.

This is the same property conveyed to grantor herein by deed of S & M Real Estate Company, Inc., recorded in the office of the R.M.C. for Greenville County in Deed Book 718, at page 89, on March 8, 1963.

This deed is made to correct the description contained in deed from the above-named grantor to the grantee herein, which deed is dated January 10, 1964, and was recorded January 10, 1964, in office of R.M.C. for Greenville County in Deed Book 739, Page 523.

And, the grantor does hereby bind itself and its successors to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s) heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
