Know All Men by These Presents That we, Florence G. Smith, H. Hoke Smith, Individually and as Executor of the M. D. Smith Estate, and Emily Lorene Smith, Individually and as Executrix of the M. D. Smith Estate do hereby grant unto the said THE CITY OF GREENVILLE, SOUTH CAROLINA, its successors and assigns, the right, privileges and easement to go in and upon that tract of land, situated in Butler Township, in the said County and State, bounded by lands of Fletcher L. and Bess G. Kirkland, H. Hoke Smith, Emily Lorene Smith, and a county road known as Black's Drive. The property affected by this right of way is the same property inherited by Florence G. Smith under the will of Marcus Dee Smith on file in the Office of the Probate Court for Greenville County, S. C. in Apt. 769, File 5, and being the same property conveyed to M. Dee Smith by deed of W. R. Smith, recorded in the RMC Office for Greenville County, S. C. in Deed Book WWW, Page 199.

to us in hand paid by THE CITY OF GREENVILLE, SOUTH CAROLINA, the receipt whereof is hereby acknowledged, do hereby grant unto the said THE CITY OF GREENVILLE, SOUTH CAROLINA, its successors and assigns, the right, privileges and easement to go in and upon that tract of land, situated in Butler Township, in the said County and State, bounded by lands of Fletcher L. and Bess G. Kirkland, H. Hoke Smith, Emily Lorene Smith, and a county road known as Black's Drive. The property affected by this right of way is the same property inherited by Florence G. Smith under the will of Marcus Dee Smith on file in the Office of the Probate Court for Greenville County, S. C. in Apt. 769, File 5, and being the same property conveyed to M. Dee Smith by deed of W. R. Smith, recorded in the RMC Office for Greenville County, S. C. in Deed Book WWW, Page 199.

* The permanent right of way after the pipe line or lines are installed shall be 40 feet in width measuring 25 feet South of the center of said pipe line as laid and North 15 feet of the center of said pipe line as laid, and no obstruction shall hereafter be placed on said 40-foot right of way.

and to construct and maintain in, upon and through said premises, in a proper manner, a pipe line or lines, air vents, blow off connections, manholes and other necessary apparatus incident thereto, using the necessary appliances and machinery for such work for the purpose of conveying water through the premises above described, together with the right at all times to enter upon said premises for the purpose of inspecting said line or lines and making necessary repairs and alterations thereon, together with the right to cut away and keep clear of said pipe line or lines all trees and other obstructions that may in any way endanger or interfere with the proper operation of or access to the same.

It is understood and agreed that the right of way to be used under this contract during construction/is to be forty feet in width throughout the entire length which is approximately 481 feet, and the damage, which THE CITY OF GREENVILLE, SOUTH CAROLINA, is to be liable for during construction, is to be confined to this strip and nothing beyond. The location of the pipe line or lines, when laid, will determine the definite location of the right of way. The center of the pipe line or lines shall be accepted as lying twenty-five feet from the South boundary line of this right of way. The remaining fifteen feet of said right of way during construction shall lie North of the center of said pipe line or lines and the entire right of way may be used for the purpose of installing the pipe line or lines. The location of said pipe line or lines is to be approximately along the line as now located and staked out by the engineers, subject to a variation of not exceeding five feet either way.

If in laying the pipe line or lines, it is necessary to cut any timber from the right of way, such timber shall be placed at the edge of the right of way on the land of the undersigned grantor and shall be the property of the undersigned grantor.

It is further understood that the owner is to have the right to cultivate and use this right of way strip of land provided such use there-of shall not interfere with the proper maintenance and free access to the pipe line or lines to be installed under this agreement. No buildings or other structures shall be placed on said right of way nearer than 25 feet from the center of said pipe line or lines.

The payment above specified covers compensation for the easement or right of way, and also covers all claims for damages, including crops growing on the right of way during construction, along said right of way resulting from construction of the pipe line or lines to be laid.

It is further agreed that in case of future damages to property or crop, due from an accident on the pipe line that THE CITY OF GREENVILLE shall pay all damages.

The undersigned agrees to release and give to THE CITY OF GREENVILLE, SOUTH CAROLINA, actual physical possession of the premises above described not later than the 1st day of August, 1964.
