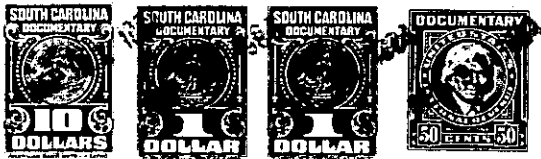
in consideration of Exchange of property valued at Six-Thousand and no/100 (\$6,000.00) Dollars,
