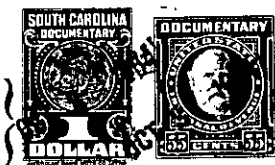

KNOW ALL MEN BY THESE PRESENTS, that we, CLARK JOHNSON AND PONEASE JOHNSON

in consideration of Five Hundred (\$500.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

ANNIE MAE KILGORE, her heirs and assigns, forever:

ALL that piece, parcel or lot of land, with buildings and improvements thereon, situate in the County of Greenville, State of South Carolina, in Butler Township, and having the following metes and bounds, towit:

BEGINNING at an iron pin in or about the center of Miller Road, in Butler Township, thence N. 59-15 W. 205 feet to an old iron pin; thence W. 51-06 E. 105 feet to an iron pin; thence S. 59-15 E. 205 feet to an iron pin on or near the center of Miller Road; thence S. 51-06 W. 105 feet to an iron pin at the beginning corner, containing 0.46 acres, more or less, bounded by the lands of Felton Wilson on the Southwest, by Clark Johnson on the Northwest and by lands of Clark Johnson on the Northeast and Miller Road on the Southeast.

This is a part of the same property conveyed to Clark Johnson and Ponease P. Johnson by deed of Ethel Irene Sheppard Jones, dated October 13, 1941, and recorded in the RMC Office for Greenville County, S. C. in Deed Book 238, page page 128.
