DAYTON BATSON, his heirs and assigns forever,

ALL that piece, parcel or tract of land in Bates Township, Greenville County, State of South Carolina, located about two miles West of Travelers Rest and being known and designated as TRACT NO. 3 containing 30.25 acres according to a survey made of the property of Porter C., Zion D. and S. Pride Batson by H. S. Brockman, Engr. dated March 30, 1964 and recorded in the RMC Office for Greenville County in Plat Book HHH, page 15 and having, according to said plat, the following metes and bounds, to wit:

McDaniel Estate, South 36-30 East 2,070 feet to a maple on a bank; running thence with the branch as the line in a Southerly direction to the joint rear corner of Tracts 3 and 2; running thence North 1-35 West 290 feet to an iron pin; running thence North 19-35 West 998 feet to an iron pin; running thence North 31-10 West 1,200 feet to an iron pin the beginning corner.
