KNOW ALL MEN BY THESE PRESENTS, that I, HENRY C. HARDING, ALICE FARNSWORTH R.M.C.

in consideration of Eleven Thousand Seven Hundred Fifty and No/100-----(\$11,750.00)----- Dollars the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JERRY J. KUEHNE and IRENE F. KUEHNE, their heirs and assigns forever:

ALL that lot of land with improvements situate on the southeastern side of Alice Farr Drive, in Greenville County, South Carolina, being shown as Lot No. 124 on a Plat of Sections I and II of WESTERN HILLS, made by Jones & Sutherland, Engineers, dated August 1959, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book QQ, Pages 98 and 99, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Alice Farr Drive at the joint front corners of Lots Nos. 123 and 124, and running thence N. 57-03 E. 237 feet, more or less, to an iron pin; thence N. 39-43 W. 100 feet to an iron pin; thence S. 75-30 W. 60 feet to an iron pin; thence S. 52-30 W. 175 feet to an iron pin on Alice Farr Drive; thence with the southeastern side of Alice Farr Drive, S. 37-30 E. 60 feet to an iron pin; thence continuing with said side of Alice Farr Drive, S. 35-19 E. 39.4 feet to an iron pin, the point of beginning.

The above described property is hereby conveyed subject to utility rights-of-way and building restrictions of public record, and to the building set-back line shown on the recorded plat.
